- If this is a request for a new account, your TradeStation account application will be submitted to TradeStation within 2 business days.
- TradeStation will establish your account and contact you via email to provide you with your log in credentials within
 2- 3 business days.
- If funding the TradeStation account, STRATA will send funds via wire within 2 business days of receiving notification that the TradeStation account has been established.

TradeStation Account Application: Complete and sign TradeStation's New Account Application if you would like to establish
a TradeStation brokerage account. Please be sure to review TradeStation's Client Agreement and Fee Schedule as well as any correspondence received from TradeStation and retain a copy for your records.
TradeStation Investment Direction: Complete and sign STRATA's TradeStation Investment Direction form. To avoid any

processing delays, please be sure to complete all sections of the form. This form authorizes STRATA to send funds from your IRA to the Investment Issuer once all documentation is provided to STRATA in good order.
